Dear Member:

Pursuant to the By-Laws, the Nominating Committee has met and issued a list of candidates 45 days prior to the election of officers at the Annual Meeting. To date, Sarah Miller is the only new name that has been nominated. She will run for Canadian at-Large. The other individuals are present members who wish to remain on the Board. There is one change which needs to be mentioned. Carol Swinehart does not wish to continue as Secretary, but would like to still serve on the Board. Therefore, we have placed her name for an at large position along with Al Eby and Sol Baltimore. For the office of secretary, John Hickey has been nominated. However, this leaves his seat as the representative from Lake Ontario open. As yet, no new name has been suggested for this position. Unless someone comes forward at Toronto that position will remain vacant.

It should be noted that this report is just a list of candidates of those individuals who have been nominated up to now. It does not rule out further nominations at the Annual Meeting in Toronto. Prior to the election nominations will be taken from the floor. This was the procedure that was followed at last year's meeting. We are particularly concerned about the vacancy in Lake Ontario. Since this Lake is just down river from Niagara, we find it disturbing that no one has come forward. We hope that by May, this situation can be corrected.

As a reminder, the Annual Meeting will be held in Toronto beginning on Friday May 11. Information on location and accommodations will be coming from the committee which is organizing the meeting. I am hoping to see all of you there.
