unweathered upper till at Site "D" as observed during certain site investigations carried out by the Town of Milton.

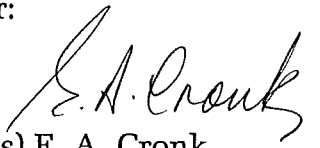

This is necessary, in our view, to ensure that all relevant evidence is before the Board to assist it in reaching its decision in this matter and to avoid any unfairness to any party having an interest in the Hearing which might be occasioned by the failure to place this evidence before the Board.
