
This timely forum is designed to provide important information about the current state of research activities and collaborative efforts between researchers from the University at Buffalo and the University of Toronto.

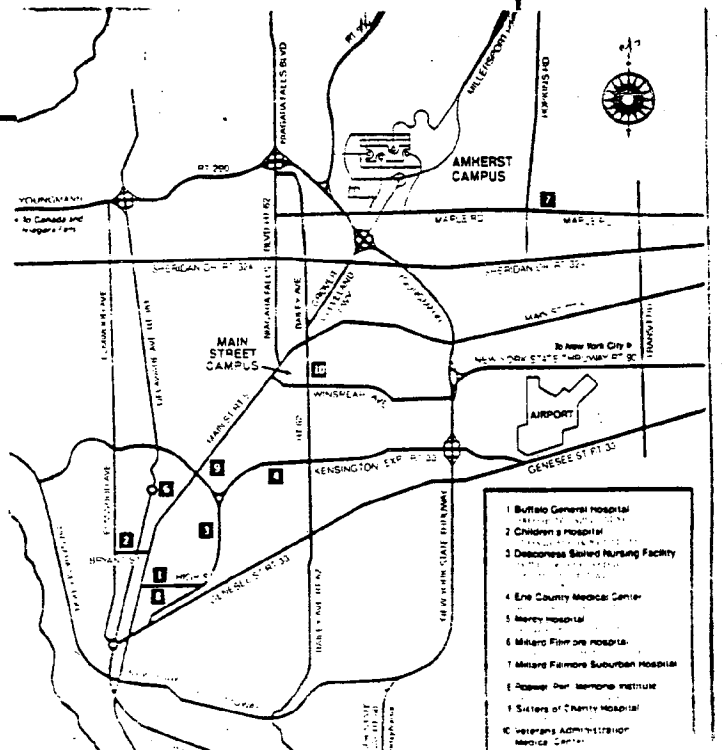
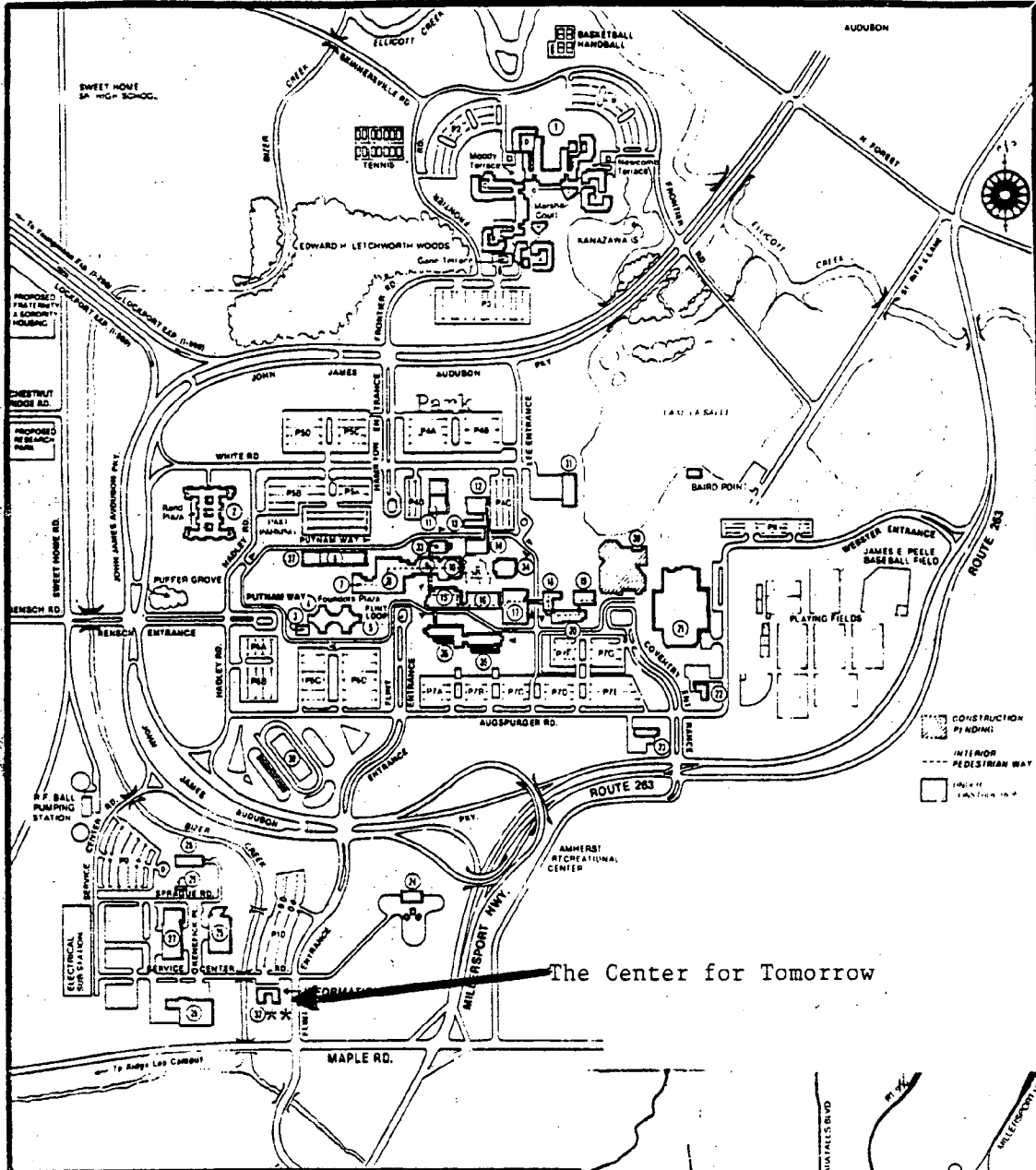
