RE: Call for Nominations

Enclosed is a list of Officers and Directors of Great Lakes United whose terms expire as of GLU's May 1994 Annual Meeting. This list indicates whether they are eligible for re-election and whether they have decided to run again for the same position.

Positions open for nominations are:

- * **All Five Officers:** President, Vice President, Secretary, U.S. Treasurer, Canadian Treasurer
- * **Three Regional Directors:** Lake Superior, Lake Michigan, Lake Ontario
- * **Five Directors at Large:** This includes three Canadian positions and two U.S. positions. At least one of the three Canadian positions must be filled by a resident of the province of Quebec.

CALL FOR NOMINATIONS

All members of Great Lakes United are invited to submit nominations for any position open for election. If you wish to submit a nomination, please ascertain first whether the potential candidate is able and willing to serve on GLU's Board of Directors. **All nominees must be members of a member group of Great Lakes United.** Please submit nominations in writing to the chair of the nominating committee and be sure to include the candidate's address, home and work phone numbers, GLU member group, and a brief description of the candidate explaining why you feel he or she would make a good GLU director.

Great Lakes United is looking for candidates who believe in the goals and principles of GLU and who will be active and dedicated in carrying out its work. This includes a commitment to attend Board meetings and to serve on GLU committees and task forces. All officers hold one-year terms; all directors hold two-year terms.

All nominations should be received by John Jackson, not later than **March 1st**, by mail at 17 Major Street, Kitchener, Ontario N2H 4R1 or by fax at (519)744-1546.

Additional nominations can be made from the floor at 11:45 a.m. on May 14 at the Annual Meeting in Buffalo.
