Re: Revised timeframe for CCME Pollution Prevention Options for Incineration

As noted in our telephone conversation, we have made significant progress on our research for pollution prevention options for incineration. However, due to the number of information material we have gathered in our research, we are unable to incorporate our findings into the draft report to meet our initial deadline of November 15, 2001. For our call on November 21st, we have completed in draft the pollution prevention options for one waste stream and commentary. As initially proposed for our call, we intend to provide a detailed overview of our research and participate in a discussion to assess the usefulness of the information presented.

To ensure that CELA's presentation of pollution prevention is as complete as possible, we are proposing the following revision to our timeframe:


DRAFT REPORT	November 30, 2001
REVIEW PERIOD (SUBMIT WRITTEN COMMENTS)	end December 7, 2001
REVISE AND SUBMIT FINAL REPORT	December 17, 2001

It is important to note that while CELA intends to fully consider all comments it expects to receive on its draft report, this CELA report is intended to provide the CCME CWS Development Committee with a range of P2 options for incineration. Therefore, we caution that this report does not intend to discuss issues that may remain contentious among stakeholders, except in areas where it provides a rationale for the P2 options presented.
