Legal Action

CELA represents Ontario residents or groups in legal actions concerning a broad range of environmental law problems. Staff lawyers regularly appear in all levels of court and administrative hearings and have acted as intervenors in many precedent-setting Court of Appeal and Supreme Court cases. CELA also provides free summary advice to the public at large.

Law Reform

The staff at CELA research and write numerous articles every year, recommending law reforms, critically evaluating new proposals, and participating in the development of new legislation.

Public Education and Outreach

CELA staff invest considerable time in public education. A knowledgeable public can play an important role in protecting and preserving a healthy and sustainable environment. In addition to public speaking activities, CELA publishes a bi-monthly newsletter, the *Intervenor*, maintains a web site (www.web.net/cela) and is home to the Resource Library for the Environment and the Law.



THE CANADIAN ENVIRONMENTAL LAW ASSOCIATION is a non-profit, public interest organization that uses existing laws to protect the environment. It advocates environmental law reforms. CELA is also a legal aid clinic and will take legal action on behalf of citizens or groups that would otherwise be unable to afford legal assistance.

CELA offers a unique articling experience, focusing on administrative/environmental law. The articling student deals directly with individuals seeking legal information, giving the student valuable practice in dealing with the public and potential clients. The articling student also gains background to the political process as part of CELA's law reform activities. Finally, there is considerable opportunity to gain litigation experience.

Articling at CELA

Law Reform. Students are given the opportunity to participate in researching and writing articles, position papers ("CELA Briefs"), and submissions under the supervision of CELA staff. There are also opportunities to appear before standing committees, city councils or commissions, and to give presentations at conferences.

Articling Activities

Legal Research and Litigation. Case work activities include legal research, writing memos and draft opinion letters, drafting motion records, affidavits and *facta*; meeting with clients, attending motions court, assisting lawyers at discoveries and hearings, and conducting corporate and title searches.

Public Outreach. Most legal inquiries from the public are initially directed to the articling student, who is responsible for researching the issue and providing an answer in consultation with one of the lawyers. Students may also write articles for the *Intervenor* (CELA's quarterly newsletter), give interviews, or deliver talks to school and community groups.

THE ARTICLING STUDENT is an important member of the team which consists of four staff lawyers, three researchers, two support staff, a librarian, a communications coordinator, and an office coordinator. Work is assigned and monitored by the staff lawyers, although there are many times when the student is required to work as part of a larger group. At the same time, with only four lawyers, articling at CELA provides

an excellent hands on learning environment. Students receive a high degree of responsibility and, as such, it is important that the student be a self-starter and be comfortable working independently.

The staff at CELA foster an office atmosphere which is congenial and cooperative. The dress code is relaxed as long as it is appropriate for the occasion. The number of hours worked each week varies depending on the caseload.

CELA usually hires one articling student each year. If you are interested in applying to CELA, you should send in your résumé with a covering letter to the attention of the Executive Director. The application process is conducted in the summer preceding the year in which your articles commence. The dates for submitting applications, scheduling interviews, and making offers are all set in accordance with the regulations published by the Law Society each spring. However, CELA does not participate in the Match Program.

Applying to CELA

ARTICLING AT CELA generally commences in July, immediately following the completion of phase I of the Bar Admission Course in May or June. The articling student is an employee of the Ontario Legal

Aid Program and the salary is set each year accordingly. OLAP contributes an additional 5.5% of the student's wages towards an RRSP. There is also an attractive benefits plan, which includes medical, dental, and vision coverage, as well as life insurance. The articling student is entitled to four weeks vacation.

CELA provides the articling student with his or her own office space and computer, which is part of a networked system. The CELA library is one of the most extensive public environmental law and policy libraries in Canada and contains a range of texts on environmental and administrative law and civil procedure, a limited selection of law reports, as well as news clippings, periodicals, and government publications on most environmental topics. Furthermore, CELA has full access to Quicklaw and the Internet. The Great Library at Osgoode Hall and the Bora Laskin Library at the University of Toronto are just a streetcar ride away.
