## Lack of Jurisdiction

- *Constitution Act*
  - Nuclear waste falls exclusively within federal jurisdiction
  - Federal jurisdiction cannot be delegated or shared
  - Responsibility of nuclear waste management cannot be delegated to the Municipality of Kincardine

## Lack of Jurisdiction

- Federal Government Jurisdiction
  - Develop criteria for appropriate disposal method for nuclear waste
  - Establish a policy to regulate and oversee nuclear waste disposal
  - Implement a policy framework for disposal of nuclear waste disposal in a safe, environmentally sound, comprehensive, cost-effective and integrated manner

## Lack of Jurisdiction

- Federal Government Jurisdiction
  - DGR cannot proceed until criteria and policy implemented by the federal government
  - Joint Review Panel does not have the jurisdiction under the *Canadian Environmental Assessment Act* to make policy relating to the disposal of nuclear waste

## Lack of Jurisdiction – Hosting Agreement

- *Municipal Act*
  - Hosting Agreement illegal and void
  - Municipality of Kincardine cannot fetter its discretion
  - Hosting agreement *ultra vires* of the municipality

## International Obligations

- International Joint Commission
  - Nuclear Task Force – impacts of nuclear activities on the Great Lakes
  - Transboundary impacts of the DGR
- 2012 Great Lakes Water Quality Agreement: Amended Protocol

## International Obligations

- CEAA, Section 5, Consideration of Transboundary Effects
- Michigan's Opposition to the DGR
  - Michigan Senate Resolution
  - Macomb County Water Quality Board
