

## **Outline of SON Presentation to the Joint Review Panel As of September 5, 2013**

---

The following is an outline of topics that SON plans to address in its presentations on September 16, 2013 and September 25, 2013. Please note this outline is not definitive and may change before presentation. In particular, the contents of SON's presentations will depend, significantly, on the content of the hearings leading up to SON's presentation.

Generally speaking, SON intends for its presentation to highlight aspects of its written submissions that are especially important to the Panel's review of the DGR Project; to help the Panel understand SON's concerns about the Project; and to discuss what SON believes are critical factors for the Panel's ultimate recommendation.

### **September 16, Opening Statements**

- Opening Prayer delivered by SON Elder
- Opening Statement by Chief Chegahno
- Opening Statement by Chief Kahgee
  - Opening Statements will focus on SON connection to the land, the significance of the DGR Project to the SON communities and their future, the importance of these hearings to understand the Project, and the continuing role of SON as stewards of the Territory

### **September 25, SON Main Presentation**

- Discussion of SON rights and interests in the study area, including:
  - SON's treaties and relationship with the Crown
  - Recognition of SON rights in the JRP Agreement
- Discussion of SON's use, reliance and cultural connection to its Territory, including:
  - Historic and current identity of SON as defined by its Territory
  - Recent developments and SON efforts to protect its Rights and its Territory
  - SON's commercial and sustenance fishery
  - SON's tourism and recreational use economy

- Discussion of potential adverse impacts on SON Rights, interests and way of life from DGR Project, including:
  - Potential for stigma
  - Fishery issues
  - Geology issues
  - Transportation issues
  - Connection between the DGR and high-level waste disposal
  
- Discussion of DGR Project, and need to demonstrate Social Safety as well as Technical Safety:
  - Nature and characteristics of the DGR Project and its risks, including:
    - Long-lived intermediate-level waste
    - Connection of the DGR Project to a future project for used fuel waste disposal
    - Permanent risk and harm to SON rights and interests
  
  - Sources of the Requirement to demonstrate social safety, including:
    - CEEA and the EIS Guidelines
    - Canadian and international nuclear waste nuclear waste management policy, standards and guidelines
    - Legal obligations to SON, including:
      - Ontario Fishing Agreement (2013)
      - MEI Agreement (2010)
  
  - Discussion of key elements of Social Safety, including:
    - Need to demonstrate public and SON confidence in assessments of technical safety
    - Need to demonstrate broad public support
    - Need to demonstrate SON support
  
- Letter agreement with OPG and the future processes between SON and OPG towards a resolution of issues and a determination of SON community support for the DGR Project.
